WE CONTINUE TO WORK ON SPECIAL PROJECT WITH HIGH SCHOOL INTERNS. WE OPENED THE DISCOVERY CENTER, A NEW MUSEUM IN DOWNTOWN FORT BRAGG, WITH EXHIBITS LIKE THE OCEAN IMMERSION 360 VIRTUAL REALITY DOME AND THE WORLD'S LARGEST FULLY ARTICULATED KILLER WHALE SKELETON, AS WELL AS AN INTERACTIVE MAKER SPACE AND HOSTED OVER 35,000 VISITORS.
